New Israel Fund is at philanthropy's cutting edge thanks in large part to SHATIL, NIF's Initiative for Social Change. NIF founded SHATIL in 1982 to complement its grant-making and provide NIF grantees and other social change organisations with hands-on assistance, training, resources and workshops on various aspects of not-for-profit management.

SHATIL employs more than 100 ethnically diverse professionals, support staff and interns, with offices in Jerusalem, Haifa, Beer Sheva, Lod, Baqa Algharbiya and Eastern Galilee, serving nearly 1,400 organisations. SHATIL has gained international respect for its innovative work and official UN recognition as an NGO advancing issues of interest to the UN.

SHATIL's work brings together organisations in large coalitions to accomplish what no single group can achieve on its own. It also carries out special projects to foster citizen action on issues and among population groups neglected by other institutions.

Today, SHATIL often takes the initiative in spearheading national advocacy campaigns and in partnering with business, academia and government to develop knowledge and skills, as well as increase access to public services for the underserved.

# 2009 Achievements

# **Civil and Human Rights**

# Separation Fence for Security, not for Convenience

The Supreme Court ordered the Israeli government to dismantle and reroute 6.6 kilometres of the Separation Fence ACRI - The Association for Civil Rights in Israel – and residents of four West Bank Palestinian villages. The ruling repeats an earlier decision that this section of the Fence must be rerouted because it is designed with the expansion of the nearby Jewish West Bank settlements in mind, rather than Israel's security. In this government to rebuild the barrier on a new route proposed by NIF grantee Council for Peace and Security, a non-partisan thousand members, each with a rich background in fields associated with security and diplomacy from the IDF. #### **Healing the Humiliation**

In a major victory in late 2009, the Israeli court awarded five Ethiopian immigrant families financial compensation for suffering discrimination against their children in preschool. Six years previously, the families' children were expelled from the municipal kindergarten in Arad because there were 'too many Ethiopians enrolled'. Represented by NIF grantee Tebeka - Center for Legal Aid and Advocacy for Ethiopian Jews in Israel, the families will be able to spend their awards on educational tools and enrichment for the children. More importantly, they will have successfully fought discrimination and defended the right of their children to participate as equals in Israeli schools.

The decision raised the spirits of the Ethiopian parents. "I never believed that the court would rule in our favour," said Nehama, Shlomo's mother. "The pain and humiliation are still there but the court ruling finally convinces us that we did nothing wrong,"



### **Social and Economic Justice**

#### **Health Care Close to Home**

After a hard-fought 18-month campaign organised by SHATIL, a new radiotherapy centre for cancer patients will open in Safed. Currently, the only radiotherapy centre in the entire Northern region is located in Haifa, forcing cancer patients to travel long distances daily for their treatment which often takes only a few minutes. The victory followed dozens of letters, phone calls, a petition, meetings with MK's, official parliamentary questions, cancer patients' visits in the Knesset and SHATIL-generated media.

# Helping Israel's Charity Sector Weather the Recession

The advocacy efforts of dozens of organisations, led by NIF/SHATIL and grantee Yedid, the Association for Community Empowerment, resulted in a government decision to increase an emergency fund for civil society organisations suffering from the financial crisis. The decision amounted to a more than threefold increase in funding for 2009 – from NIS 30 to NIS 100 million – and an additional NIS 100 million for 2010. Additional tax breaks will also be available for the organisations.




### Tel Aviv Municipality Pledges Employment Rights to Cleaners

A senior Tel Aviv Municipality official has promised that all future tenders will contain clauses, which will ensure contractors are committed to pay employees and employees of subcontractors their full salary and entitlements

The move came in response to a letter from NIF grantee Kav LaOved – Worker's Hotline, which drew the municipality's attention to the fact that many refugees employed by subcontractors to undertake cleaning and maintenance work for the city had not been paid their salaries. The municipality said it is now committed to enforce the new tender clauses.

#### **Rights for Gay Families**

In another precedent-setting achievement for the rights of same-sex couples, an Israeli woman was granted a widow's pension by the government's National Insurance Institute following the death of her partner. Ella Bar-llan, who will receive the pension, was represented by NIF grantee New Family, which promotes recognition of all forms of family units and equal eligibility for rights and entitlements.

# **Everyone Should Be Able to Marry in Israel**

In August 2009, Nico Tarosyan and Olga Samosvatov were married in the first-ever public non-Orthodox Jewish wedding held in Israel, funded and organised by NIF and grantees Havaya – Israeli Wedding and Fishka Club. Nico is one of the more than 300,000 Israelis who are prohibited from marrying in Israel because they are unable to prove their Jewish status to the rabbinate, or who are Jewish only on their fathers' side. The event raised awareness worldwide of the need for civil marriage in Israel.



# **Shared Society**

### Fairness for Israel's Diverse Population

Following the deaths of three children in recent years, the Israeli government agreed to allocate £12.3 million to pave roads to nine schools in the Negev, serving eight recognised and five unrecognised Bedouin villages. Additionally, five years after the Negev Bedouin village of Darijat was recognised by the Israeli government, the 900 residents have finally been connected to the national water grid and have running water in their homes. The victories are part of NIF's campaign to win full government recognition of unrecognised villages, and ensure that all Bedouin villages have the same infrastructures and services as their Jewish neighbours.

### Kicking Racism Out of Israeli Football

For the first time ever, the Israel Football Association (FA) deducted a league point as punishment for the racist chanting by a team's fans. During one match, Betar Jerusalem's fans repeatedly sang chants insulting the prophet Mohammed and Arabs. The Israel FA disciplinary committee based their evidence on the reports of the volunteer observers in NIF's campaign to Kick Racism Out of Israeli Football. Betar was also ordered to play one game without spectators. The Israel FA's strong stand sends a clear message to all clubs and fans that racism is not to be tolerated.

At the end of the 2009 season, NIF crowned the Bnei Yehudah football team as having Israel's fairest supporters – lowest on the weekly ratings of violence, incitement and racism.

# UK Task Force on Issues Facing Arab Citizens of Israel

In autumn 2009, New Israel Fund joined the Pears Foundation, UJIA, The Abraham Fund Initiatives, Board of Deputies and Zionist Federation in establishing the UK Task Force on Issues Facing Arab Citizens of Israel. Its purpose is to deepen UK Jewish engagement and understanding of the challenges facing Israel's Arab citizens and leverage communal resources to provide effective solutions. NIF is proud to take a leading role in this new Forum towards these ends.

# Holding On to Green Space in Jerusalem

Putting an end to a nine-year struggle, the Jerusalem District Planning and Construction Committee formally approved the plans for a 64-acre urban park in Gazelle Valley instead of developing the land for high-rise buildings of flats. The victory was the result of a grassroots effort led by the residents of one of Jerusalem's most disadvantaged neighbourhoods, which has no other significant green spaces. The residents were empowered by SHATIL and NIF grantees, particularly Community Advocacy: Genesis Israel. The Society for the Protection of Nature in Israel. supported by NIF through the Green Environment Fund, has been active in planning the new park.

A wealth of high-profile speakers from Israel, such as Rabbi Michael Melchior, Avram Burg, Dr. Tzvia Greenfeld and Prof. Naomi Chazan, toured the UK to speak at numerous events. This heralded a tremendous year for NIF's Educational and Events Programme, doubling the number of programmes and participants on the previous year, bringing to NIF many new supporters.

'Israel Question Time' and lively New Generation (young adult NIF) evenings generated vigorous debate and dynamic interaction.

The well established annual Human Rights Awards Dinner with 2009 winners Helmi Kitani (Shared Society) and Anat Hoffman (Religious Pluralism) resulted in wide exposure for New Israel Fund and our work on these issues.

The breakfast series hosted by APAX Partners initiated in late 2008 was expanded, proving a huge success with an invited audience of key supporters and leaders of the Jewish community. These breakfasts focused on NIF core issues such as, equality for Palestinian citizens of Israel, Religious Pluralism, Democracy, Social Justice, Israel-Diaspora Relations and Women's Rights.
